

Thomas Carrique, O.O.M., became the 15th Commissioner of the Ontario Provincial Police on April 8, 2019. He commenced his policing career with York Regional Police in 1990, working in a variety of roles and progressing through the ranks, serving as Deputy Chief of the Administration Branch, the Operations Branch, and the Investigations and Support Branch. Commissioner Carrique holds a Master's degree in leadership and training, with a specialty in justice and public safety, from Royal Roads University, and a certificate in terrorism studies from the University of St. Andrews in Scotland. He is a recipient the Police Exemplary Service Medal and the Queen Elizabeth II Diamond Jubilee Medal. He is also an Officer of the Order of Merit of the Police Forces as well as a Serving Brother of the Order of St. John Ambulance.



Mark Crowell Chief of Police of the Waterloo Regional Police Service (WRPS), Ontario. He has served 22 years with WRPS in a variety of operational and administrative roles. Mark is a member Canadian Association of Chiefs of Police (CACP) Victims of Crime Committee and the CACP Ethics Committee. He holds a Master of Arts degree and a Ph.D. in Sociology from the Department of Sociology and Legal Studies at the University of Waterloo.



Grant Edwards, is a 34yr veteran of the Australian Federal Police having enjoyed a diverse career across all crime types, including serving internationally in Afghanistan and Timor-Leste, Washington D.C, and Los Angeles in multi-functional roles. He holds a master's degree in leadership, policy, and governance, a Graduate Diploma in Executive Leadership, a Graduate Certificate in Policing Studies, and a Bachelor of Arts majoring in Anthropology. His personal mental health lived experience with PTSD was shown on Australia's ABC's Australian Story in 2017. In 2019, following his retirement from the AFP he published his memoir book titled "The Strongman".



Dr. Ian Hesketh, PhD, is the Wellbeing Lead at the UK College of Policing and the Senior Responsible Owner (SRO) for the National Police Wellbeing Service in the UK. In 2012 his article on Transforming Leadership was voted one of the top 5 Management Articles by the Chartered Management Institute, and in 2020 he was the recipient of a Literati Award from Emerald for an Outstanding Paper for research on Psychological Screening in Emergency Service Responders.



Dr. Katy Kamkar, PhD, CPsych is a clinical psychologist at the Centre for Addiction and Mental Health (CAMH) in Toronto. She is an Assistant Professor, Department of Psychiatry, University of Toronto. She is the Chair of Global Law Enforcement and Public Health Association Inc. (GLEPHA), Health and Wellness of Police/ First Responders; and Past Chair of the Canadian Psychological Association (CPA) Traumatic Stress Section. She was awarded the 2022 Canadian Psychological Association (CPA) Award for Distinguished Contributions to Public or Community Service.



Rob Martin is a Deputy Fire Chief with the city of Brampton, Ontario and former Deputy Fire Chief, Kitchener fire department, Ontario. With over 25 years in the fire service, he has acquired a wide range of experience while filling progressively more senior roles. He has a mission to bring a holistic approach to Public Safety Personnel Wellness strategies.



Dale McFee, O.O.M., is the Chief of Police, Edmonton Police Service, Alberta. He is the former Deputy Minister of Corrections and Policing in the Ministry of Justice for the Government of Saskatchewan and was the Senior Deputy Minister involved with leading transformational change. He is also former Chief of Police for the Prince Albert Police Service, Saskatchewan. Chief McFee is the past President of the Canadian Association Chief's of Police, a former Chair of the Federal Provincial Deputy Ministers and former Co-Chair of Canadian Criminal Justice Association (CCJA) within Stats Canada. He has lectured extensively on leadership and change management nationally and internationally.



Shahin Mehdizadeh, M.O.M., is the Chief of Police Lethbridge Police Service, Alberta. He was a member of the Royal Canadian Mounted Police (RCMP) for many years serving many communities in Canada, assisting on several large scale national and international investigations, and is the former Chief Superintendent, District Commander, RCMP, Central Alberta District, Edmonton, AB.



Benoit Mulsant, MD, MS, FRCPC is the Labatt Family Chair of the Department of Psychiatry at the Temerty Faculty of Medicine, University of Toronto, and a Senior Scientist at the Centre for Addiction and Mental Health (CAMH), Toronto. He is a Fellow of the Royal College of Psychiatry (Canada), a Distinguished Life Fellow of the American Psychiatric Association, and a Distinguished Fellow of the American Association for Geriatric Psychiatry.



Paul Pedersen, O.O.M., is the Chief of Police, the Greater Sudbury Police Service, and Past President of the Ontario Association of Chiefs of Police OACP. Chief Pedersen has more than 40 years of exceptional police experience having served in progressively senior leadership positions with York Regional Police Service and now serving as Chief of Police for the Great Sudbury Police Service. Paul's leadership experience covers all aspects of policing, including responsibilities for frontline operations and investigative services and is supported by a strong academic background. He holds a Master of Public

Administration from Western University. He is the proud recipient as an Officer of Order of Merit of the Police Forces and the Queen Elizabeth II Diamond Jubilee medal as well as being invested as a Member in the Order of St John.



Andy Rhodes OBE QPM is the former Chief Constable of Lancashire Police, United Kingdom. Up until retirement in 2021, he was chair of the Chief Police Officers Staff Association CPOSA, Chair of the Board of Trustees of the North West Police Benevolent Fund, and the National Police Chiefs Council lead for well-being and organisational development. In 2015 he established the first National Police Well Being Service - Oscar Kilo, supporting over 200,000 officers and staff, which he continues to support as Service Director. He was awarded the Queens Police Medal in 2017 and an Order of the British Empire OBE in the 2022 birthday honours for services to emergency service workers mental health.



Dr Katrina Sanders MBBS FRACGP MPH, is the Global Chief Medical Officer Aspen Medical and former Chief Medical Officer Australian Federal Police. She had also served as a Senior Medical Officer in the Australian Army.

Norm Taylor has been an independent advisor, educator, author and researcher for over 40 years, concentrating his practice in the field of policing and public safety for the past three decades. In addition to serving as the founding EIC for the JCSWB since 2016, he also co-founded and has served as Program Director for the Canadian Association of Chiefs of Police (CACP) Executive Global Studies, where he has led learning and research teams into 51 countries since 2003. Norm also serves as an executive advisor to senior leaders in policing, public health partner agencies, and governments in Canada and the USA.



Dr. Peter Voore MD FRCPC, is the Medical Director of the Acute Care Program at the Centre for Addiction and Mental Health (CAMH). He is an Associate Professor in the University of Toronto's Faculty of Medicine. In 2014, Dr. Voore received the Mary Seeman award for clinical excellence from the University of Toronto. In his varied roles he has worked to improve quality care, patient access to acute care and specialized services and lead the initial development of Integrated Care Pathways at CAMH. He was Co-Chair of the Health Quality Ontario HQO Expert Panel advising on the development of the Quality Standards for Major Depression. He has recently conducted external reviews of the mental health services at the University Health Network in Toronto,

Ottawa Hospital, Kingston General Hospital, Trillium Health Partners, St. Joseph's Healthcare PES in Hamilton, Whitehorse General Hospital and conducted a review for the Hospital for Sick Children in Toronto to become a Schedule 1 facility under the Ontario Mental Health Act.
