### 5. Partnership/Collaboration Criteria

- 8.2. Prosecutors SIG Nick has been working to new convenors as this SIG has languished.

# 9. Other Updates

9.1. Justin advised he is part of an Ethics Group a component of the Vulnerability and Policing Futures Research Centre, part of ESRC (the Economic and Social Research Council). This group will examine how police interact with vulnerable populations and offer advice on better ways for police to interact with these populations. The ethics of these approaches is critical to public confidence and has led to the creation of an independent group for scrutiny.

#### 10. Conference Updates

- 10.1. Umea 2023 the conference has only two pre-conference sessions planned at this point. The organisers are looking for more pre-conference sessions. Otherwise, the conference seems to be gathering a good level of interest.
- 10.2. Community Safety and Well-Being Conference, April 2023. Lauren has been working with Chief Dale MacPhee (Edmonton Police Servicer) on planning a conference with CSWB as a primary

theme. This would be the first such conference. There is an opportunity for GLEPHA to be a sponsor and to be a contributor.
