

Metropolitan Football Survey (2000)

Each time they were at the club:

• 42% drank

25% drank

• 7% drank

- 13% under 20's
- 32% drank at the club 3-4 times per week
- 83% travel to & from the club by car, as the driver



# **Less Risky Drinking**

- Each level of accreditation:
  - reduces the chances of short-term risky drinking among members by 15%.
  - reduces the chances of long-term risky drinking among members by 14%.
  - Reduces risky drinking by 20% on match day.




# **Lowered Risks of Drink Driving**

- Lower BAC among drivers:
  - Average BAC 54% lower at Level 3 clubs (0.05) than non Good Sports clubs (0.11)
  - Average BAC 40% lower at Level 3 (0.03) than Level 1 (0.05)
- More designated drivers:
  - 68% at Level 1 compared to 74% at Level 3; and 52% at Level 1 compared to 65% at Level 2.




# Relative Contributions - Level 1




# Partnerships – LGA's

- Major sponsor for majority of sporting clubs

# **Partnerships – VCGLR**



- Enabled RSA courses and Club liquor Licensing Seminars to be delivered outside of registered training organisations;
- Result increase in courses across Vic; operate during evenings; subsidised cost structure; increased responsible alcohol practices operating in clubs;
- RSA Certificates provided free of charge;
- New Entrant Training part of ADF's Club Liquor Licensing Seminar courses – unique for sporting clubs;
- ADF involvement in focus groups and restructure of courses;
- Good Sports presentation to VCGLR Compliance Inspectors
- Good Sports noted within VCGLR's strategic plan.



### Partnerships – RoadSafe Looking After Our Mates



### Looking After Our Mates Sessions for Good Sports Clubs

Looking After Our Mates (LAOM) is a FREE program delivered by Good Sports in partnership with RoadSafe North West and RoadSafe Westgate

The Looking After Our Mates resource has been developed by Vic Roads, RoadSafe Victoria, Victoria Police, Traffic Accident Commission (TAC) and the Australian Drug Foundation. It is a drink driving information session with a simple, effective message about responsible drinking, safe driving – and looking after your friends

It consists of a 45 minute session delivered by a trained facilitator covering topics such as the effects of alcohol on the body and on performance, the law and Blood Alcohol Concentration (BAC), drink driving as a road safety issue and strategies to avoid drinking and driving.

Good Sports clubs in the following LGA's are eligible to host a LAOM session:

- > Brimbank
- > Hobsons Bay
- > Hobsons E > Hume
- > Maribrynong
- > Melton > Wyndham

Clubs taking up this offer will receive a set of 10 A line hygienic 'safe design' drink bottles and holder with Good Sports and Looking After Our Mates logos valued at \$150. (pictured)

### Partnerships - Police - Case Study: Creswick FNC

### **History**

- Magistrate ordered a Creswick man to run an alcohol education seminar for his football club after he was caught drink-driving following a club event;
- Imposed the mandatory license suspension of 16 months;
- No conviction recorded instead ordered him to organise, co-ordinate and run an alcohol road safety awareness program through the club.

### What they did!

- Club submitted an article to the local paper promoting an upcoming Club Liquor Licensing Seminar;
- Conducted the Club Liquor Licensing Seminar involving 30 club delegates.

### **Partnerships – Victoria Police**



### Victorian Police strategy

#### Overall -

 To reduce the incidence of alcohol related harm associated with community sporting clubs throughout Victoria through a coordinated strategy involving Police, the Australian Drug Foundation (Good Sports), and Good Sports contracted Community Partners.

### Specific -

- Increased contact between Police and Community Sporting clubs via random visits of licensed sporting clubs;
- To have a greater understanding of the Good Sports
  program, including its delivery structure and the assistance
  the program provides to local sporting clubs.



# Lessons leant along the way

- Greater awareness of issues facing clubs
- Critical role Police play
- Critical role VCGLR including Compliance Inspectors

# Challenges -

- Matching ADF's club priorities with key stakeholders
- Movement of Police Local Area Commanders

### Measures of success

- Majority Police Area Commands now include sports clubs / ADF or delivery partners in local accords
- Communication by Police to ADF with concerns over club liquor management
- Improved coordination between Police and VCGLR
- Improvement in communication between Police and ADF's delivery partners

# Measures of Success – continued...

- Appears to be more consistent and effective approach by police when assessing and recommending approval of various license conditions attached to sporting clubs
- Many Local Area Commands have now established dedicated police units targeting alcohol related issues in licensed premises including sporting clubs

## Measures of Success – continued...

- Attendance by Police at Club Liquor Licensing Seminars
- Examples of Police Inspectors using these licensing seminars and RSA courses as a means of –
- > communicating more effectively with clubs
- educating their own personnel on sporting club issues
- Local success Mornington Peninsula
